### "And the norms and notions of what 'just is' Isn't always justice."

I've been thinking a lot about the wisdom of inaugural poet Amanda Gorman lately. Her poems are all about maintaining hope, taking action, and creating the future we wish to live in. To me, her two lines above sum up exactly why we must do all three of those things.

When I find myself grieving yet more lives lost to gun violence or hearing the heartache in a survivor's story, I'm reminded of two other lines by Amanda Gorman that give me focus and guide me forward:

> "May we not just grieve, but give. May we not just ache, but act."

### **Get to Know Tubman Legal Services** Increasing their safety, elevating their voices, and advocating for survivors



#### **Criminal Court Advocacy**

Victims of domestic assault and related crimes receive help from legal advocates who provide information on the court process and meet with victims at court.

#### **Orders for Protection (OFP)**

Tubman legal advocates write and file Orders for Protection, and assist at Order for Protection hearings in Hennepin, Washington, and suburban Ramsey counties.

#### Family Law Pro Bono Representation

Tubman staff attorneys and volunteer attorneys provide pro bono (free) legal representation to low-income people with family law cases in Hennepin, Washington, and Ramsey counties.

#### **Law Clinics**

Volunteer & staff attorneys meet oneon-one with clients for 30-minute sessions concerning family law and other legal issues

#### Self-Represented Law Clinics

Volunteer & staff attorneys meet oneon-one with clients for a two-hour session designed to help people represent themselves in family law cases.

#### Legal Services for Immigrant Families

Tubman partners with Immigrant Law Center of Minnesota and Esperanza United to provide comprehensive legal advice, brief services and legal representation to immigrant families fleeing relationship violence.

#### **The Safety Project**

Pro bono (free) legal representation to low-income victims of domestic violence, sexual assault, and stalking who are seeking Orders for Protection and Harassment Restraining Orders in Hennepin, Ramsey, and Washington counties.

#### Sexual Assault Clinic at Aurora Center

Tubman partners with the Aurora Center at the University of Minnesota to provide on-campus & remote legal advice and representation to University of Minnesota and Augsburg College students who have experienced dating violence and/or sexual assault.

### **Did You Know?**

Tubman actively practices prevention by calling domestic abuse victims and survivors to see how we can best support them and their family.

A key way a victim's voice is heard in a criminal case is through writing a victim impact statement. Tubman advocates for clients to ensure they are able to share their thoughts and experience during the criminal court process.

Tubman serves three metro counties, Hennepin, Washington, and Ramsey, but only receives funding from 2 of the 3 counties we serve, and the funding we DO receive only partially covers our costs.

### Legal Services By the Numbers

- Tubman legal advocates have written 4,433 safety plans in the past eighteen months.
- 838 Orders for Protection and Harassment Restraining Orders were written and supported in the past eighteen months by advocates and attorneys.
- Tubman provided criminal court advocacy for 3,016 clients in the last eighteen months.
- Our dedicated law enforcement intervention line has received over 1,871 calls in the past eighteen months. We helped create safety plans and offered shelter resources, while they were on the scene of a domestic violence call.

# Tubman's Legal Services Support Survivors on their Journey from Fear to Freedom

For over 45 years, Tubman has served survivors of domestic violence in the Twin Cities metro area as a multiservice organization serving adults, youth, and families.

In 1977, Tubman began offering legal services to clients, starting with legal advice and information on family law matters. Over the years, additional services have been added such as criminal and civil legal advocacy through Orders for Protection and Harassment Restraining Orders, and support in domestic violence related criminal cases. Legal advocates have supported the implementation of lethality assessments, which identify the cases most at risk of ending in homicide and offenders most likely to reoffend, provide immediate services for victims, and support an argument for higher bail and closer supervision for offenders. The establishment of the Freedom Fund also provides clients with emergency cash assistance for tangible safety needs such as lock replacements, security systems, help with moving costs, and more.

Today's services at Tubman have even more scope and serve clients in Washington, Ramsey, and Hennepin Counties. Our legal team helping survivors move from fear to freedom is comprised of advocates, case coordinators, staff attorneys, and volunteer attorneys who provide services such as: criminal court advocacy (suburban Ramsey County and Washington County) in domestic violence related criminal cases, civil advocacy in Orders for Protection (OFPs) and Harassment Restraining Orders, pro bono representation for family law cases, law clinics, selfrepresented legal clinics, partnerships to provide legal services for immigrant families, sexual assault legal clinics, and The Safety Project providing pro bono representation in protective order hearings for victims of violence.

In the last eighteen months we've seen an increase of over 12% in services provided, with fewer staff, resources continuing to decline, while the costs of doing this work continue to rise.

Creating comprehensive responses to domestic violence victims and survivors is an integral aspect in holistically supporting victim-survivors and their families seeking safety and stability. Whether someone is referred to us, seeks us out directly, or is contacted by our team after law enforcement intervenes, we aim to make the process feel more comfortable and safe. "Clients do reach out to us for support and services, but what many do not realize is that we also reach out to the clients after an incident occurs. We also partner with law enforcement who call us from the scene of a domestic violence call, to connect clients with shelter and safety planning options in the moment of immediate need." – said Jena Reed, Tubman's Director of Legal Services.

"Advocates are often the first and potentially the only access point for victims to understand and receive support through any involvement in the legal system." Jena says, "Most people don't know they need us, until they need us. A lot of people have never interacted with the legal system, so it can feel really overwhelming and inaccessible. Having someone on their side can be a huge relief."

# Tubman's Legal Services Support Survivors on their Journey from Fear to Freedom

In criminal court, Tubman's advocates play an especially important role in supporting victims and survivors. In fact, advocates are the primary point of contact for victims to confidentially provide input, ask questions, and receive updates during the process.

If advocates are not present to work with a victim, one could utilize the prosecutor for support, however they are usually overwhelmed with all of the other types of charges

and responsibilities to provide the level of emotional support and resources a survivor needs and deserves.

Further, since the pandemic and the requirement of remote court appearances, offenders are less likely to be taken into custody for bench warrants and other charges, leaving a victim feeling powerless. "Having support from someone, like an advocate, provides a more personal ally who can help victims and survivors avoid feeling dismissed or like another number in a big system that often feels like it sides with those in power – the abuser," Jena shared.

Our attorneys and advocates support clients through difficult processes, such as writing Orders for Protection and Harassment Restraining Orders. "Protective orders are intended to be a resource for individuals to pursue protection on their own, but it can be difficult for people to write a petition that meets the statutory requirements without the support of an advocate," Jena shared, "Additionally, abusive parties will often use the legal system as an additional form of abuse, forcing victims into court multiple times, or making baseless allegations that

attorneys more often, further perpetuating the imbalance of power. With the support of Tubman attorneys and advocates in person at court or via remote court hearings, victims are more likely to achieve positive outcomes and a feeling of empowerment that may not have occurred otherwise. Providing attorney services when a victim may not have otherwise been able to afford them allows for the opportunity to resolve cases outside of court, preventing the trauma that may be experienced if a survivor or their minor children would have needed to testify in court. Additionally, our attorneys have extensive knowledge about the dynamics of domestic violence, which means that safety is the top priority in divorce, child custody, or child support cases.

As we continue to see an increased need for services while funding continues to be divested, we feel great concern knowing many survivors and victims will not receive the help and support they need to feel safety, hope, and healing. "Unfortunately, the need for our services is not going away," Jena adds, "And with legal systems that are confusing and complex, survivors deserve our support when they are experiencing crisis."

#### **Demand Rises, Resources Dwindle**

"Since the pandemic, we've seen an increase in demand for services, the costs of doing this work continue to rise, and our overall funding for legal services continues to decline." said Jena Reed, Director of Legal Services at Tubman. Cases are also becoming intricately more complex and time consuming. These circumstances are creating challenges which are requiring us to examine whether we continue to provide all of these services as we are, or if we will need to pull back on offerings. "The increase in demand, paired with the decrease in funding creates obstacles to support and is putting our clients in more danger," said Jena.

Tubman provides legal services for the community in three counties. While Hennepin and Washington Counties provide some funding (at the time of this writing, Ramsey County does not), the funding doesn't cover the full costs of the services Tubman provides. "Additionally. Tubman receives referrals from other agencies who are unable to provide, or simply don't have the services we do for clients in need." Jena said. "And an already challenging situation may become even more dire, if our federal Legal Assistance for Victims grant is not renewed at the end of this year. The bottom line is, we do not have enough resources to meet the needs of people in our community who need our help." Creating pathways to safer spaces and getting protections for survivors and their family members who may fear for their safety is our primary concern, and we need your help.

Your support for Tubman's legal services provides lifechanging measures for victims and survivors. And your gift can exponentially impact those in need. For instance, providing funding for one Order for Protection or Harassment Restraining Order may impact multiple people by providing safety for a parent, their children and other family members. Supporting the cost of a security system for a family in danger provides not only the safety needed, but the peace of mind to begin moving forward.

Supporting adults, youth, and families experiencing domestic violence is about more than emergency shelter or calling the police. In fact more often than not, immediate legal support can help individuals leave an unsafe home or stay safely in their current home, preventing homelessness. Tubman's legal services provide protection for people at risk and in danger, support and amplify victims' voices in the judicial system, provide education on their rights, and guidance as they make their way from fear to freedom.

## **Program Highlights**

#### Shelter

Our shelter programming remains dedicated to an experience which feels welcoming, holistically caring, and mindful to the needs of people we serve through hosting events and experiences such as a "Pamper Yourself" event in honor of Mother's day, with haircuts, styles, and nail treatments, Juneteenth celebrations, HIV testing and education, and Summer of Peace programming for kids with activities such as tie dying, a field trip to the zoo, and water fun to stay cool!

#### Clinical Services

Our mental and chemical health services remain focused on accessibility by offering online services, as well as increasing in-person programming as safety allows, thoughtfully focused on removing barriers which may impede clients receiving support when needed. Additionally, some programming has evolved, such as our parenting group, which is now the Health Relationships group open to all femaleidentifying clients, which includes parenting and relationship skills, boundaries, safety, wellness, and communications skills.

#### Legal Services

Legal services continue to both serve clients and the community through various ways such as hosting a Minnesota Justice Foundation fellow interning with our attorney team, partnering with other agencies to host an Advanced Order for Protection (OFP) Mock Trial training, served on various interview panels for local police departments, and participating in county council subcommittees to recommend and shape changes that may be needed in cases involving domestic violence.

#### Housing & Youth

Our housing and youth programs continue to build depth in our communities through various partnerships, such as paid internships in our violence prevention initiatives via Minneapolis' Step Up program, drum & dance workshops through the Minnesota State Arts Board and theater workshops via the Minnesota Regional Arts Council, our Economic Advancement program co-created with survivors in partnership with Hennepin County, and transformative partnerships with property managers who are helping survivors experience safer, longerterm housing option with comprehensive support.

### Welcome to our Incoming Board of Directors

This Spring we welcomed five new Board of Directors to Tubman, and said goodbye to a couple of outgoing board members as well. Join us in welcoming Latrina Caldwell, Sarah Erickson, Christina Kolles, Marissa K. Linden, and Mary Lucic to their first board term!

### **VAWA Reauthorized**

Last year we hosted U.S. Senator Amy Klobuchar for a press event highlighting the importance of reauthorizing the Violence Against Women Act (VAWA). Since 1994 when it first passed, VAWA created responses to domestic violence, sexual assault, dating violence, and stalking. However, VAWA must be reauthorized every five years, and while it passed in the U.S. House of Representatives in 2021, it failed to do so in the U.S. Senate.

We continued to advocate for the reauthorization of VAWA with our coalition partners by writing and calling legislators asking for their support of this bill, and for the expansion of its existing protections to better meet the needs of survivors. This hard work and coalition building paid off, and VAWA was reauthorized and signed into law by President Joe Biden in March of 2022. In addition to this success, the so-called 'Boyfriend Loophole' was closed in gun legislation that passed in June, which prohibits the purchase of firearms by dating partners who have been convicted of domestic violence.

A special thanks to all of you who continue to use your voice by writing and calling your legislators for legislation that supports survivors and victims of domestic violence. Thank you.
